### Overview

He develops creative solutions that lead to victory for his clients, drawing on more than 30 years spent in the courtroom trying cases and crafting compelling arguments to focus on what matters most: articulating the facts, telling his client's story, and connecting with juries.

   Affirmed on appeal.
